- O How long after I begin the course will I have access?

Your responses are for your own use; no one else will see them, and they will not be stored permanently. While you cannot print out the answers to these questions, you will be able to review them all on the "Detailed summary" page at the very end of the course. If you would like to keep your responses, we recommend writing them down or typing them out elsewhere on your device, such as in a Word document.

While you cannot print out the summary of key takeaways, you can access all additional resources there or at any time using the "Resources" menu in the top-right corner of your screen.

Supported Browsers: LearnUpon supports the following browsers and versions:

Browser Settings: These are browser settings required for LearnUpon to work correctly across the above browsers:

Cookies should be enabled in order for logins to work.

- Flash should be enabled where SCORM, Tin Can, and video have been set to playback with Flash. Where Flash is not enabled, those mediums revert to playback with HTML5.
- JavaScript should be enabled.
- Pop-up blockers can cause problems on some browsers from time to time, so if the users can add LearnUpon to their pop-up blocker exception list that would be preferable.

Operating Systems:

- Windows Desktop: LearnUpon currently supports Windows versions 7, 8, and 10.
 However, there are some browser limitations, as outlined below:
 - Internet Explorer 11 will be fully supported for Windows 8 and 10
 - Internet Explorer 11 for Windows 7 will be fully supported for the foreseeable future, however, this will be further reviewed at the end of 2019.
- Mac Desktop: LearnUpon currently supports that last two major macOS releases.
- Mobile/Tablet:
 - iOS We recommend using at a minimum iOS 11.0.
 - Android We recommend using at a minimum using Android 6.o.
